Attached below is a letter from Canada Revenue Agency (CRA) stating that CRA will lift its liens according to certain conditions being met. Bidders should be aware that they will need to deal directly with CRA on this matter should they submit the winning bid.

It is possible the liens will not be removed from title until after the bidder takes title to the property and accordingly bidders should be aware they are accepting this additional risk.

The City does not have discretion to extend the maximum 14 day closing period as outlined in Ontario Regulation 181/03 under the *Municipal Act*, 2001. As outlined in the regulation, in the event the highest bidder does not close the transaction within the 14 day notice period, the deposit will be lost and the second highest bidder will have an opportunity to purchase the property, under similar conditions.




